Today, my attention has been drawn to an order dated 06.09.2019 passed in W.P.(C) 466/2016, wherein the Division Bench had directed the Delhi Government to release part of Victim Compensation Fund not less than Rs. 25,00,00,000/- to DLSA within a period of 10 days from 06.09.2019.

On the same line of reasoning, it is directed that the Delhi Government shall release a sum of Rs. 15,50,00,000/- being second instalment to DLSA within 10 days from today in order to meet some of the claims of rape victims.

All the counsels representing the party are at liberty to take complete Court record in accordance with Delhi High Court Practice Directions.
