- 2. Learned counsel for applicant submitted that by way of present application, prayers are made to allow the applicant to travel abroad for a pious pilgrimage during the period from April 2025 to September 2025. He further submitted that against the above referred judgment and order of conviction, appeal has been preferred, and the same is admitted. That, even this Court is pleased to suspend the sentence and grant him bail. That, appeal being of 2016, there are no prospects of appeal being taken earlier. He further submitted that applicant intends to go for Haj Pilgrimage, it is compulsory in his religion. Therefore, he seeks permission to travel abroad during the period from April 2025 to September 2025. He further pointed out that his wife, brother, and brother's wife, who will accompany him, have been allotted slots by the Haj Committee. Only because of pendency of appeal, applicant is required to apply for grant of permission. Hence, this application.
- 3. Learned counsel for respondents submitted that necessary orders be passed.
- 4. In view of the grounds raised in the application, and as appeal is of the year 2016, and there is no immediate chance of appeal being taken for hearing, for religious purpose, application deserves to be allowed. Hence, the following order.
