Leave granted.

We have learned counsel for the parties.

The only redeeming feature in the case of the appellant is that fortunately there was no acid injury on the complainant but only two drops of acid were found on her mobile phone. Learned counsel for the appellant submits that these are false allegations arising out of rivalry. The fact however, remains that this is a second incident of which the complaint has been made. We are informed that 4 out of 7 witnesses have been examined and thus all private witnesses have been examined. The appellant has been in custody for more than a year.

VERDICTUM.IN

In view of the aforesaid facts and circumstances, we grant bail to the appellant on terms and conditions to the satisfaction of the trial Court.

Apart from any other conditions imposed by the trial Court, the following conditions shall also stand imposed:

- 1) The appellant will not enter Agra where the complainant resides till the Court proceedings conclude, except attending to the Court proceedings,
- 2) The appellant shall not, in any manner, come within the vicinity of the complainant.

In case, any endeavour is made to breach the aforesaid conditions or any other conditions imposed by the trial Court, the trial Court is within its rights to cancel the bail granted to the appellant.

The appeal stands disposed of.
