A supplementary affidavit has been filed in Court today. Let it be taken on record and numbered by the office.

Perused the supplementary affidavit filed by the petitioner who alleges that in order to browbeat him into withdrawing this Public Interest Litigation, which relates to illegal felling of trees belonging to the Government in *gata* no. 122 of *Gaon Sabha*-Pahur, Pargana & Tehsil- Bindki, District- Fatehpur, respondent no. 9 assaulted the petitioner's brother and other members of his family on 22.05.2022.

When the family members of the petitioner approached the police Station, respondent no. 9, who appears to be a man of criminal propensities, worked his connection with the Police and got an FIR lodged against the petitioner and the complainant, who had originally complained the matter, whereas the FIR lodged by the petitioner's side was registered later on at 11.21 p.m. on 25.05.2021. The ninth respondent's FIR was deliberately got lodged by the Police of Police Station- Kalyanpur, District-Fatehpur at 6.55 p.m. in order to give advantage to the ninth respondent.

It is also asserted in the supplementary affidavit that respondent no. 9 is a criminal and accused in a murder case registered as Case

Crime No. 74 of 2018, under Section 302, 201 and 34 IPC and Section 3,5 and 25 of the Arms Act, Police Station- Panvel Taluka, District- Raigad, State- Maharashtra.

What is most perturbing is the fact that there is a definitive allegation in paragraph no. 9 of the supplementary affidavit that respondent no. 9 is still threatening the petitioner's father, mother and brother asking them to withdraw the present Public Interest Litigation. The petitioner has also asserted in paragraph no. 10 that there this will bring a great peril to his entire family.

No one in the country can threaten or obstruct a person from approaching the Court and seeking his remedies. This is the biggest impediment affecting the course of justice and, therefore, the most serious of criminal contempts.

Before we pass any orders in the matter, we order respondent no. 9, Narendra Singh, son of Badlu Singh, resident of Village- Pahut, Police Station- Pahur, Tehsil- Bindki, District- Fatehpur to **appear** in **person** before this Court on **13.08.2025** at **2.00** p.m.

Notice shall be served upon respondent no. 9 through the Chief Judicial Magistrate, Fatehpur within 24 hours.

The Superintendent of Police, Fatehpur is ordered to ensure that notice is served upon respondent no. 9 in all events.

Let this matter come up as **fresh** on **13.08.2025 at 2.00 p.m.** 

In the meantime, the Superintendent of Police, Fatehpur will file his own affidavit by the next date fixed regarding this case of manipulation and taking sides, as the petitioner alleges, with respondent no. 9 by the Station House Officer, Police Station-Kalyanpur, District- Fatehpur.

This order shall be caused to be served upon the learned Chief

Judicial Magistrate, Fatehpur and the Superintendent of Police, Fatehpur by the Registrar (Compliance) within 24 hours.
