ORDER

Heard the learned Senior Counsel Sri.P. Vijayabhanu,
as instructed by Sri.P.K. Varghese.

2. The offences alleged against the petitioners in
Crime No.41/2025 of Cantonment Police Station,
Thiruvananthapuram, are under Sections 11(i) and 12 of the
Protection of Children from Sexual Offences Act. The 1st
petitioner is the Consulting Editor and the 2nd petitioner is the
Sub Editor-Digital of a Malayalam News Channel known as
'Reporter'.

3. Admittedly there is no grievance to the victim
child and the parents of the child. The maximum punishment
that can be imposed for an offence under Section 12 of the
POCSO Act is below three years. Therefore I am of the
considered opinion that the petitioners are entitled interim bail.
