### COMMON ORDER

[Order of the Court was made by S.M.SUBRAMANIAM, J.]

An unfortunate event of custodial death of one Mr.Ajithkumar, aged 29 years, is the subject matter of the batch of Public Interest Litigations on hand filed by the people residing in the village, advocate etc.

2. Primarily, the State contended through the learned Additional Advocate General that actions are initiated by the State Government. F.I.R. was registered initially and thereafter, it was altered and Section 103 BNS has been added. Five Police Constables from the Special Team are arrested and they are placed under suspension. They are remanded to judicial custody. Further actions are initiated to accelerate the investigation. The investigation of the case on hand has now been transferred to CBCID, who in turn is in the process of receiving case papers. Thus, the writ petitions are unnecessary.

3. Learned Additional Advocate General would further submit that the State will initiate all further appropriate actions against the officials, including the higher officials, for their lapses, negligence, participation etc. Since the writ petitions are at the admission stage, two to three days time is required for the Government to make necessary assessment for initiation of all appropriate actions against the officials, who are responsible for the custodial death of Mr.Ajithkumar. The State has conceded the custodial death in the present case.

4. Respective learned counsels on behalf of the writ petitioners would strenuously contend that action initiated by the State Government is insufficient. Misdeeds of the higher officials are attempted to cover up. Suspension of five policemen is an eyewash and they want to hide the custodial death under carpet. An impartial probe is just and necessary. Since the District Police in entirety joined together and attempted to cover the misdeeds and burry the custodial death of one young person, who is working as a Guard in the Badrakali Amman Temple at Madappuram, this Court should step in and initiate all appropriate actions.

5. The facts in nutshell as narrated by the petitioners in their writ petitions reveals that on 27.06.2025, one Smt.Sivakami and her daughter Nikitha went to Madappuram Badrakali Amman Temple at Madappuram, situate at 20 Kms., away from Madurai City. The said two women approached the temple guard

Mr.Ajithkumar (deceased) to provide a wheelchair. They further requested the deceased Ajithkumar to properly park their vehicle with the assistance of some driver. The deceased Ajithkumar acceded to the request of the two women devotees. On their return, they found that approximately 9 sovereigns of gold jewels kept inside the car was missing. They gave a complaint to Thiruppuvanam Police Station on 27.06.2025 during evening hours. One Mr.Ramesh Kumar, Inspector of Police, Thiruppuvanam Police Station, immediately contacted the Executive Officer / Assistant Commissioner of the Temple, who in turn directed the temple guard Mr.Ajithkumar and plumber Mr.Kannan to go to Thiruppuvanam Police Station and explain the facts. Accordingly, Ajithkumar and Kannan went to Thiruppuvanam Police Station and explained the facts before the Inspector of Police. The Inspector of Thiruppuvanam Police Station allowed them to leave the Police Station after conducting enquiry. Admittedly, no FIR was registered at that stage. FIR was registered on the next day i.e., on 28.06.2025 in Crime No.303 of 2025 for the offence under Section 103(1) of BNS.

6. It is stated that the Inspector of Police, Thiruppuvanam Police Station, contacted the Special Team constituted by the Deputy Superintendent of Police, Manamdadurai, at the instructions of the Superintendent of Police and asked them to conduct investigation. Admittedly, the Special Team consists of one Head

Constable and five Constables. The said Special Team is functioning under the control of the Deputy Superintendent of Police, Manamadurai and now, the said Deputy Superintendent of Police is placed under suspension.

7. On the particular day, the Special Team was headed by one Mr.Kannan, Head Constable. He took the custody of the deceased Ajithkumar on 27.06.2025. The said Ajithkumar was taken to a veterinary hospital, Puthur, during night hours on 27.06.2025, wherein he was brutally attacked by the Special Team policemen. Subsequently, one Mr.Arun and Mr.Navinkumar (brother of the deceased Ajithkumar) were also taken into custody by the Special Team and they were also beaten by the Special Team policemen. The Special Team thereafter taken the deceased Ajithkumar to Adi Dravidar Boys Hospital at Madappuram on 28.06.2025 during morning hours. There also, the deceased Ajithkumar was brutally attacked by the Special Team policemen. Thereafter, the deceased was taken to a private grove, namely, Ayothi Thoppu. The Special Team conducted search operation in the residence of the deceased Ajithkumar, but no recovery was made.

8. Again the Special Team took the deceased Ajithkumar inside the temple premises and kept him behind the office of the Executive Officer / Assistant Commissioner of the Temple, nearby the the cowshed. In the said place, the deceased Ajithkumar was brutally beaten up with lethal weapons and chilli powder

was poured on his face and private parts. On 28.06.2025, during evening hours, the Special Team took the deceased Ajithkumar to a Private Hospital, namely, Dr.Baskar's hospital, wherein the Doctor refused to provide treatment to the deceased Ajithkumar. The deceased Ajithkumar was thereafter taken to Government Hospital, Thiruppuvanam, in an autorickshaw, wherein the Doctors declared him brought dead. The mother and brother of the deceased Ajithkumar were staying in the Thiruppuvanam Police Station and they asked the Police about the whereabouts of the deceased Ajithkumar. No information was given by the police officials in the Police Station. Pertinently, the Superintendent of Police was very much physically present in the Thiruppuvanam Police Station on 28.06.2025 during night hours. The dead body of Ajithkumar was thereafter taken to the Government Rajaji Hospital, Madurai. Immediately, the mother of the deceased Ajithkumar gave a complaint to the Thiruppuvanam Police Station on 29.06.2025 at 02.00 a.m., in the morning hours and till this time, no FIR has been registered by the police, despite the fact that the Government Doctors at Thiruppuvanam Government Hospital declared him dead on 28.06.2025 during evening hours.

9. Adding to the above facts, regarding the custodial death of the deceased Ajithkumar, learned counsels appearing for the respective petitioners would submit that three prominent persons / office bearers of the ruling DMK party

along with the Deputy Superintendent of Police had a meeting in Nadar

Uravinmurai Kalyana Mandapam at Madappuram and had compromise talks to  
settle the matter. In the said compromise talks, an offer was made to pay a sum of of  
Rs.50,00,000/- to the family of the deceased and government job will be provided to  
the brother of the deceased. It is further contended that Dr.Nikitha, Assistant  
Professor working in a College / de facto complainant is known to an IAS Officer  
and through him, the de facto complainant informed the Superintendent of Police  
for strenuous action against the alleged incident of theft of gold jewels.

10. In response to the allegations set out by the petitioners, the learned  
Additional Advocate General appearing for the official respondents would submit  
that the FIR has been registered at the first instance and further investigation alone  
will reveal the facts regarding the allegations raised in the writ petitions. The State  
has taken the case seriously and will ensure that a fair and impartial investigation is  
conducted through a Special Investigation Team of CBCID. Therefore, the facts  
placed by the petitioners on the one hand and the case is being custodial death,  
which is serious in nature, sometime is required for the State to initiate all  
appropriate actions against the higher officials, who are all responsible and  
accountable for the custodial death of an young person Mr.Ajith Kumar, The First  
Information Report has been initially registered against five Police Constables in

said five policemen are arrested.

11. The learned Additional Advocate General for the official respondents would further submit that the Government will show its bona fide by initiating all further appropriate actions in a short span of time, since the present writ petitions are at the admission stage and actions to be initiated against the policemen of the Special Team and other higher officials will also be considered by the Government.

12. Since a serious doubt has been raised about the destruction of evidences and material objects, the respective learned counsel appearing for the petitioners would urge this Court to provide necessary protection to the eyewitnesses and also to preserve the evidences.

13. It is brought to the notice of this Court that some of the evidences have already been destroyed and the scene of occurrence has not been properly preserved and one Additional Deputy Superintendent of Police, namely, Sukumaran went to the scene of occurrence and collected the evidences by himself in gunny bags in an unusual manner and therefore, serious view is to be taken.

14. This Court asked the learned Judicial Magistrate, Thirupuvanam, to submit a report, who in turn, has immediately submitted a report before this Court.

On account of the tensed situation prevailed on the particular date in Thirupuvanam Village at nearby scene of occurrence, the learned Judicial Magistrate was not in a position to conduct enquiry and record the statements. Therefore, he immediately left the scene of occurrence by stating that he will summon the persons concerned and conduct enquiry thereafter. It is brought to the notice of this Court that staff members of the Judicial Magistrate Court, Thirupuvanam, also went on leave, since a tensed situation was created by the Police in that locality and it is a Town Panchayat.

15. We have requested the Dean, Government Rajaji Medical College and Hospital, Madurai, to submit postmortem report, who in turn, submitted the same by stating that it is a preliminary postmortem report and final report will be submitted after receiving laboratory reports, which are awaited.

16. A plain reading of the nature of the injuries inflicted on the body of the deceased would reveal that he was brutally attacked all over the body and died. Even an ordinary murderer would not have caused this much of injuries to a person is the view of this Court. He is not even an accused as on 27.06.2025 and no First Information Report for theft was registered. Importantly, there is no previous criminal case against the deceased person and he had no bad antecedent and he was working as a Watchman in the local temple. Therefore, the local people know about



him and his character. The father of the deceased died in the year 2004 and the mother brought up her two children and the deceased is the eldest son.

17. The material evidences are unsafe in the hands of the local police, who are all directly or indirectly interested parties to the custodial death. We have enquired about the preservation of the CCTV footages. The Executive Officer of the Temple, who is present before this Court, informed that one Sub Inspector of Police, namely, Ramachandran has taken entire CCTV footages along with DVR and hard disk.

18. The learned Additional Advocate General appearing for the official respondents informed that the CCTV footages collected from the temple are kept in the office of the District Special Branch (Technical Wing).

19. The present custody and status of the CCTV footages, including whether a clean copy was made in the presence of an independent official or Magistrate and what chain of custody protocols have been maintained. Whether any forensic certification of footage was undertaken and whether any tampering is ruled out is also a question to be investigated. The respondents however are bound to ensure that original CCTV footages and any mirror copies made thereof are preserved intact and not subjected to any deletion, overwriting or editing.

20. In view of the preliminary facts placed before this Court and

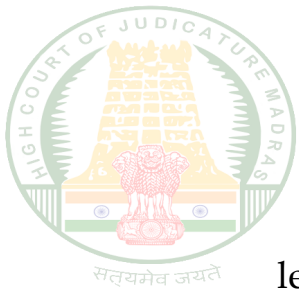

considering the fact that the State has conceded that it is a case of custodial death due to brutal attack caused by the Special Team, this Court is inclined to pass the following interim order:-

- (i) This Court requests Mr.S.John Sundarlal Suresh, learned IV Additional District Judge, Madurai, to conduct a thorough enquiry into the custodial death of the deceased Ajith Kumar by commencing the enquiry forthwith and submit a report before this Court on 08.07.2025;
- (ii) As per the statement of the learned Additional Advocate General, the State Government shall initiate all appropriate actions against the higher officials, who are all responsible and accountable for the custodial death of the deceased Ajith Kumar and submit a status report before this Court on or before 08.07.2025;
- (iii) The Inspector of Police, Superintendent of Police and the Investigating Officer are directed to hand over the case file, CDR Records of the higher officials and the Special Team members, including Deputy Superintendent of Police, Inspector of Police and also the de facto complainant and the CCTV footages to the learned IV Additional District Judge by 02.07.2025 and the

learned IV Additional District Judge shall keep all the evidences in a safe custody at Madurai District Court Campus until further orders; and

- (iv) The State shall provide necessary protection to the eyewitnesses to the case.

21. List the matter on 08.07.2025 for further consideration.
