### <u>O R D E R</u>

- Leave granted in SLP(CRL.) No.14286/2024,
   SLP(Crl) No. 1217/2025, SLP(Crl) No. 1283/2025, SLP(Crl) No. 2598/2025 and SLP(Crl) No. 2072/2025.
- 2. We have heard the learned Additional Solicitor General (for short, the 'ASG') appearing for the CBI, the learned ASG appearing for the Directorate of Enforcement, the learned Senior counsel, and counsel appearing for the parties, at length.
- 3. In all of these matters, the appellants/petitioners have been arrayed as accused either for the predicate offence or for the offences punishable under Sections 3

- and 4 of the Prevention of Money Laundering Act, 2002 (for short, 'the PMLA') or for both.
- 4. Learned Senior counsel and other counsel appearing for the appellants/petitioners made the following submissions:

Some of the co-accused in these matters have already been granted bail. The roles have which been attributed to the appellants/petitioners who are before us, are less serious when compared to that of those who have already been granted bail. This Court has taken note of the fact that the trial is going to be prolonged due to the voluminous documents filed by the Investigating Agencies and the huge number of witnesses named. The appellants/petitioners have been under incarceration for more than one year. For some of them, bail has neither been granted in the predicate offence nor in the PMLA offence and in cases where bail has already been granted in the PMLA offence, they are entitled to bail in the predicate offence as well.

Taking into consideration the above, the impugned order(s) passed by the High Court will have to be set aside, particularly when in some of the orders, the High Court has taken into consideration the rigor of Section of the PMLA while dealing with predicate offence. In any case, the said rigor would not apply in view of the decision rendered by this Court in 'V. Senthil Balaji Director, Directorate The Deputy Enforcement' in Crl. A. No.4011/2024 26.09.2024, as there is a bounden duty not only on the part of the Court but also on the part of the prosecution to ensure that the trial is concluded within a reasonable time period, which is not likely to take place in the present matters.

5. Mr. S.D. Sanjay, learned ASG appearing for the CBI and Mr. S.V. Raju, learned ASG appearing for the Directorate of Enforcement submitted that the allegations made against the appellants/petitioners are serious. Gullible victims have been deceived of crores of money.

In all these cases, money has been laundered seen from the documents filed by the Investigating Agencies. After the money was laundered, it was taken to Dubai and thereafter, brought back to India through hawala transactions with the able assistance of the appellants/petitioners before us. The main accused are yet to be apprehended. Therefore, on the peculiar facts of the case, there is no need for any interference.

- 6. Mr. S.D. Sanjay, the learned ASG appearing for the CBI submitted that in those cases where the CBI is undertaking the investigation, a period of two months may be given as further investigation is going on.
- 7. Taking note of the submissions made by the learned ASG appearing for the CBI, we are inclined to adjourn the SLP(Crl) No. 703/2025, SLP(Crl) 2367/2025, SLP(Crl) No. 1364/2025, SLP(Crl) No. 1528/2025, SLP(Crl) 1909/2025, SLP(Crl) No. 2199/2025, No. SLP(Crl) 2229/2025, SLP(Crl) No. No. 1993/2025, SLP(Crl) No. 2580/2025, SLP(Crl)

- No. 2602/2025, SLP(Crl) No. 3587/2025, SLP(Crl) No. 3500/2025 & SLP(Crl) No. 4867/2025, to be taken up on 25.09.2025.
- 8. This leaves us with the appeals involving the PMLA offences. As submitted, some of the coaccused have already been granted bail by the High Court and by co-ordinate Benches of this Court. We have also taken note of the roles attributed to the appellants. Though their roles are varied, taking into consideration the period of incarceration and that the trial is likely to be delayed, we are inclined to grant bail.
- 9. Accordingly, the impugned order(s) stand set aside and the appellants are granted bail, subject to the terms and conditions that may be imposed by the Trial Court.
- 10. The Trial Court shall impose an additional condition directing the appellants to file an undertaking that they will not be involved in any similar offence in the future, either directly or indirectly.
- 11. The Trial Court shall also impose a condition

that all the appellants shall report before the Trial Court once a week, apart from impounding their passports.

- 12. Liberty is given to the prosecuting agency to seek cancellation of bail, in the event of any of the conditions to be imposed by the Trial Court, being violated.
- 13. Accordingly, the appeals stand allowed.
- 14. Pending application(s), if any, shall stand disposed of.
