

Official statement and Letter of Condemnation (22.05.2023)

Members are informed that as per Press Release of Pakistan Bar Council the Sindh High Court Bar Association shall observe a full day strike on Monday, May 22 2023 as a mark of complete protest against decision of Indian Government for holding G20 Tourism Working Group meeting in dispute territory of Srinagar, India llegally Occupied Jammu &Kashmir (10JK) and to express solidarity with the people of Jummu and Kashmir.

In light of the above, in exercise of the powers conferred upon the undersigned by Rule 43 of BCPH

Rules, an emergent agenda item highlighting the above stated matter was circulated amongst all Members

of State Bar Council for their views, whereby a unanimous resolution has been passed which is as under: -

"It has been resolved that this notice/resolution issued by the Sindh High Court Bar Association,

Pakistan Bar Council, Sindh Bar Council, as reported in media, is to be condemned in the strongest

words. An official statement and letter of condemnation be issued in this regard by the worthy

Chairman BCPH."

As directed by the General House, the undersigned is issuing the following statement and letter of

condemnation on behalf of Bar Council of Punjab & Haryana in this regard.

State Bar Council of Punjab & Haryana strongly condemns the press release/communique/resolutions

passed by Sindh High Court Bar Association (Karachi, Pakistan), Pakistan Bar Council & Sindh Bar

Council in the harshest possible terms. While beautiful Srinagar extends a warm welcome to all

international G20 delegates at the 3rd TWG meet, such press release/communique/resolution is not in

the right earnest and smacks of desperation. Such mendacious statements are only designed to suit

oblique political motives. Such Bar bodies, attempting to engineer hatred have unscrupulously toed

the line of the current political dispensation in Pakistan.

Kashmir is an integral part of India and futuristic people of Kashmir only want progress and

development similar to the rest of India. They have rejected Pakistan's false narratives and stand

united in the pursuit of a better future.

While India entered the G20 presidency with its humble resolve of 'One Earth • One Family • One
