Sub: Urgent and pressing issues of the Bar Dear Sir.

This letter is addressed regarding certain pressing issues of the Bar warranting immediate intervention by your good offices.

Allocation of additional space to the Supreme Court Bar Re. Association (SCBA).

You will appreciate that the SCBA being the apex Bar Association of the country requires a proper office for its President, its Secretary as well as a big room for its Committee meetings. We also require a proper lunch room where lawyers who carry lunches from home and those who do not have chambers, can sit and have lunch there. The present lunch room is highly inadequate for our members. As the strength of lawyers is increasing by 200-300 every year and no additional space has been created for the members to wait for their matters, there is also a need for an additional library for our members in an area proximate to the courtrooms.

During my first tenure as President of the Bar (2017-2018), I had got an assurance from Hon'ble Mr. Justice Dipak Misra (the then Chief Justice of India) to give us the entire Annexe building in front of court No.11 where we could have the office of the President, office of the Secretary as well as a Committee Room, and the remaining space was to be allocated by having a library and a lunch room for the members of the Bar. The lawyers have to be in close proximity to courts which is why the Annexe building was found to be most convenient -- the entire backside of the building comprising court No.6 to court No. 15 could be easily accessed. The said additional space would be highly beneficial in controlling overcrowding in courts as lawyers,

bereft of any place to wait for their matters, are forced to crowd courts. The Annexe building was to be made available when the new building at Appu Ghar complex was to come up where it was agreed that the Registry which is occupying the Annexe building will be shifted to the new building to make room for SCBA. It is disheartening to note that despite additional space designated to the Supreme Court in the Appu Ghar Complex which facilitated a comfortable shift of a host of offices from the present building, no commensurate place was allotted to SCBA.

The issue has been previously brought out by the undersigned in multiple letters (dated 02.03.2021, 31.07.2021, 21.09.2021, 06.01.2022) as well as in meetings of the Executive Committee of SCBA with the Hon'ble Chief Justice of India on various dates, however, no action whatsoever has been taken in this regard

It comes to us as a great surprise that the said Annexe building is being considered to be made a Museum by the Supreme Court when the request for providing the Annexe Building of the Supreme Court for utilization of the SCBA is pending consideration by your good offices.

It is not out of place to mention that there is only one ladies bar room in the entire Supreme Court premises and the same remains overcrowded. There is a dire need of an additional ladies bar room which is proximate to the courtrooms where ladies can sit while waiting for their matters.

I would earnestly request you to immediately allot adequate space in the Annexe Building to SCBA to provide for a more proximate library, a lunch room, additional ladies bar room, rooms for the President, the Secretary and Committee Room for the Executive Committee of SCBA.

Allotment of chambers to the Bar Council of India Re. (BCI):

Vide my letter dated 29.08.2022 addressed to your good offices, a request was made to cancel the allotment of 3 chambers in the Appu Ghar Complex in favour of BCI and the said chambers along with the 26 chambers kept reserved for consultation room

be de-reserved and the entire 29 chambers be given to SCBA for the use by our members.

The said request was made as BCI has no statutory role to perform in the premises of the Supreme Court and accordingly there is no justification of allotting them those chambers. Infact the BCI has its own independent building very near to the Supreme Court and granting them 3 chambers from out of the chambers meant for our members would deprive 6 of our members from being allotted chambers who have been waiting for such allotment for more than 2 decades.

The issue was raised before Hon'ble Mr. Justice N.V. Ramana, the then Chief Justice of India, who had orally promised to reverse the decision but apparently he could not take any final decision in this regard before his retirement. The issue has again been raised in our letter to your good self dated 29.08.2022 wherein it was informed that the Executive Committee of the SCBA has also resolved to seek cancellation of the allotment of the said three chambers to the BCI. We have also verbally taken up this issue in a meeting with your goodself.

The above is a highly important issue for the Bar and our members want to sit on dharna opposing such an allotment. On my assurance that the issue is under consideration of the Hon'ble Chief Justice of India, the matter is not being precipitated. Even from a plain reading of the Allotment of Lawyers' Chambers Rules (as amended upto 30.11.2007), it is clear that the Hon'ble Chief Justice of India can only make allotments upon the recommendation of the Committee for allotment of chambers. Clearly the issue of allotting chambers to the BCI has never been placed before the Committee for allotment of chambers of which the undersigned is a member and hence, the allotment, if any, is non-est and void and liable to be recalled forthwith.

Further, request was also made to covert the three large vacant halls in D-Block of the New Additional Building into cubicles for the use of members of SCBA. Also, 7-8 big halls in the

Subject: Issues of the Bar pending consideration

Dear Sir,

You have always been deeply concerned about the issues of the bar and have been receptive to the suggestions made by the Executive Committee of SCBA, re-assuring us that as the head of the Institution, you would not hesitate in taking immediate and necessary steps in addressing all such issues.

The issues of the bar were discussed in detail in our last meeting and the undersigned had also addressed the same vide letters dated 31.05.2021, 06.07.2021, 31.07.2021 and 30.08.2021, however, till date no action appears to have been taken. The important issues that need your immediate attention are as under:

1. Resumption of physical hearing – The system of issuing special passes for the high security area should be dispensed with in the SOP issued by the Secretary-General on 28.08.2021. Entry to the high-security area should be permitted by the use of a proximity card and the waiting areas would be the libraries and the lounges where lawyers will wait on their own after observing covid protocol. If those areas were to get full then the lawyers can easily wait in the corridor which is like being in an open space where minimal restrictions are required. Further, as the number of covid cases in Delhi/NCR has fallen considerably and positivity rate in the

national capital is 0.04%, you may consider full resumption of physical hearing. [Ref. letters dated 06.07.2021 and 30.08.2021]

2. Senior Designation – In terms of the 'Supreme Court Guidelines to Regulate Conferment of Designation of Senior Advocates, 2018', the 'Committee for Designation of Senior Advocate' is obliged to meet at least twice in a calendar year. However, there has been no such meeting in the last 2 years.

Further, in the meeting of the Full Court dated 27.03.2019, it was resolved that the pending applications of 2018 would be considered in the next meeting of Full Court. Therefore, a Full Court meeting is required to clear the pending names.

- 3. Chambers for members the New Chamber Block at the Appu Ghar Complex has been built and ready since 2018-19, however the same remains unallotted till date. Preparation of Seniority List for allotment of chambers to be expedited so that allotment of chambers can be done at the earliest. [Ref. letter dated 06.07.2021]
- 4. Additional Chambers Expediting the construction of lawyers' chambers in 1.33 Acres of land allotted to the Supreme Court of India behind petrol pump near ITO. [Ref. letter dated 06.07.2021]

Issues of the Bar pending consideration

for long

Dear Sir,

I am writing this letter with deep sense of anguish regarding non-consideration of several pending issues of the Bar. We are now getting a feeling that the SCBA, since it has never resorted to strike in its history, is not being given its due importance.

Pending issues:

Sir you will recall that the issue of elevation of members of SCBA to various High Courts was taken up at your instance and for the said purpose we constituted a very credible Search Committee to identify names for consideration for elevation. The Search Committee met several times and finally identified 48 names for being considered for elevation in various High Courts. The said names were handed over to your good self personally by the undersigned several months back. The timing of the deliberations of the Search Committee was very important as there are a large number of vacancies in various high courts and the Collegiums of the high courts are in the process of recommending names for elevation. Our entire exercise will be futile if the respective collegiums were to recommend names for elevation without having before them the names of the members of SCBA. You will appreciate that we have not claimed any priority in the appointment but have merely sought for consideration by the Collegium so as to ensure that the best names are recommended for elevation. The entire exercise was also to bring more transparency in the exercise of appointment to the Higher Judiciary which is repeatedly being alleged to be under a cloak of secrecy. As per our information, none of the names suggested by the Search Committee have been considered by any of the High Court Collegium.

As far as the allotment of chambers is concerned, a decision had been taken by the earlier Executive Committee alongwith the Judges Committee to change the partition walls of the chambers so as to make 3 chambers out of 2 for the purposes of single allotment. It was also decided to make cubicles in the big halls provided in the said building to accommodate lawyers who are waiting for allotment of chambers. Inspite of our repeated request, the final chamber allotment list was not prepared in a time bound manner. However, recently we have been told that the same is ready but the said list has not been handed over to us till date. We have been corresponding with the Registry to find out the progress of work in terms of the decision of last Executive Committee and we were told that no work has started to re-design the same. We were also trying to get the allotment list to find out if we could request members to chose their partners from the list and make the allotment to the chamber as it exists today without any alteration but that effort also could not fructify due to delay in finalising the list. A building which is ready in every aspect is laying vacant and unused due to delay in allotment of chambers.

We have been asking for extra space for the Association to provide for a more proximate library, a lunch room and rooms for the President and Secretary of SCBA in the annexe building in front of Court No. 11 which was verbally assured to us by the then CJI Dipak Misra in my last term as President and followed up by me in my present term as well, however, till date no action has been taken in this regard. Sir, the present lunch room is a dingy small room where many Senior Advocates and Advocates practicing in this court have lunch and it is sad that so much of additional space was made available to the Supreme Court in the Pragati Vihar area which resulted in moving out large number of office from the present building but no commensurate place was allotted to SCBA.

Since the beginning of my present tenure, I have been requesting for making available the Auditorium and the meeting rooms for the functions/meetings of SCBA but the same has been denied to us without any justification. I have pointed out in my several letters to your goodself that the additional land was made available due to the persistence of the SCBA which had filed a petition in that behalf for the removal of Appu Ghar and giving the

additional land to the Supreme Court. Though the lands were given due to the persistence of SCBA, neither was SCBA given any additional space in the existing building (as mentioned above) and to add insult to injury SCBA was debarred from using the Auditorium during the tenure of Mr. Rakesh Khanna the then President, SCBA. This debarment was not in the public domain and was brought to our notice by the Secretary General when we requested for the Auditorium to bid farewell to Justice Indu Malhotra. I have written several letters on this subject and was verbally assured several times, however, no decision taken on the same has been communicated to us till date.

That with regard to virtual hearing being conducted by this Court, we have been repeatedly requesting that the present system of virtual hearing is not at all acceptable to the Bar especially the feature of advocates not having the right to Mute/unmute themselves. The present system clearly militates against the concept of open hearing because lawyers do not have any right to enter a proceeding of his/her choice or to mention a matter or to even ask for a suitable date because of the control of the court master/court staff in deciding to mute and unmute a lawyer. In none of the High Courts of this country this control is being exercised by the court staff and the lawyers are permitted to mute and unmute themselves. This also gives an impression that our voice is not being heard favourably because we do not go on strike whereas high court lawyers resort to the same whenever their demands are not met. Initially we were told that the software being used by the Supreme Court does not permit this feature, however the software has been with technological and several times upgraded advancement, it is clearly not possible that such feature cannot be incorporated in the virtual hearing of Supreme Court when the same is available in the virtual hearing of all the high courts across the country.

We have also been representing from the beginning that large number of matters are not being listed inspite of mentioning and for some unknown reasons, a lot of category of matters are not being listed for preliminary hearing. In this regard, it is submitted that our demand is mercly that all matters filed should be listed strictly on the basis of date of filing and the bar should always have the right to make an urgent mentioning for listing of

matters. Both these aspects remained unresolved till today.

In terms of the 'Supreme Court Guidelines to Regulate Conferment of Designation of Senior Advocates, 2018', the 'Committee for Designation of Senior Advocate' is obliged to meet at least twice in a calendar year. Inspite of our request, no steps have been taken in the last 2.5 years to call for applications from advocates for senior designation.

We have been requesting for expediting the construction of additional lawyers' chambers in 1.33 Acres of land allotted to the Supreme Court of India behind petrol pump near ITO. Till date no steps have been taken in this regard and the said land is lying vacant.

It is therefore requested that an urgent audience be granted to the Executive Committee of SCBA to discuss the above issues and necessary action be taken at the earliest.

Sub: Some important and pressing issues of the Bar

Dear Sir,

First of all, on behalf of the Executive Committee of the Supreme Court Bar Association (SCBA), I would like to congratulate you on assuming office as the 49th Chief Justice of India on Saturday i.e., 27th August 2022. Is it indeed a proud moment for SCBA as a lawyer regularly practicing in this Court has taken over the reins of the highest judicial office of this Country. matters have been listed and we are hopeful that very soon the backlog of matters required to be listed are cleared soon.

While allotment of chambers, the registry gave us chamber numbers to allot in the new building and after the allotment process was over, we were told that 29 chambers on the ground and first floor were not given to the Bar as 3 of them have been allotted to the Bar Council of India (BCI) and 26 have been reserved as consultation chambers. The said allotments were done without consultation with us.

As regards 3 chambers given to the BCI, we strongly and vociferously object to the same as BCI has no statutory role to perform in the premises of the SC and accordingly there is no justification of allotting them those chambers. Infact the BCI has its own independent building very near to the Supreme Court and granting them 3 chambers from out of the chambers meant for our members would deprive 6 of our members from being allotted chambers who have been waiting for such allotment for more than 2 decades.

The request of BCI for 3 chambers is also otherwise unfair, as till date neither the undersigned nor the Secretary of SCBA has any chamber in the entire Supreme Court campus. We have been fighting for a proper Committee Room for our Executive Committee meeting as well as a proper office for the undersigned and the Secretary however the same has been denied to us till date. That the Executive Committee of the SCBA has also resolved to seek cancellation of the allotment of the said three chambers to the BCI. We request that the said allotment in favour of BCI should be cancelled forthwith and the said chambers along with the 26 chambers kept reserved for consultation room be given to us for the use by our members.

The three large vacant halls in D-Block of the New Additional Building have to be converted into cubicles as already discussed earlier. Further we also find that there are 7-8 big

halls in the adjoining E-Block which are also lying completely vacant and the same can also be used either for construction of chambers or cubicles. We hope that decision in this regard will also be taken very soon.

Another very serious issue regarding the new chambers is the problem being faced by our members in accessing the same. The Supreme Court registry has declared that area as even more high security as the Supreme Court campus with the result that our members are facing difficulty in accessing those chambers. The DCP incharge of security has informed the undersigned that there are no security issues from his side and the Policemen are not allowing free access to our drivers, clients and other staff who will now be required for renovation of these chambers, only at the behest of the Supreme Court Registry. Immediate action needs to be taken to permit free access to the new chamber building.

We are hoping that you will address all our genuine concerns at the earliest.
