- 6. Affidavit of service is taken on record.

It has been brought to the attention of the Court that few girl students of the same College have been shown in various channels and social media which is likely to create an impression that the female shown would be the victim whose identity should be preserved and not disclosed under any circumstances. It demeans the modesty of the victim and the female who have been shown with a mistaken identity. If required, an advisory shall be issued by the State Home Department to all the media houses and to lodge appropriate complaints if in the social media any such attempt is made to confuse the identity of the victim.

- 9. The victim is represented by Mr. Yuvraj
 Chatterjee, Advocate-on-record led by Mr.
 Arindam Jana, Advocate.
- 10. The petitioners are directed to serve copies of the writ petitions upon Mr. Yuvraj Chatterjee in course of this week.
- 11. The victim shall be heard in both the writ petitions.
