- On 10.08.2022, it was noted that the mother of the applicant, Mrs.
 Neena Arora aged 61 was diagnosed with acute Myocardial Infarction
 (STEMI Anterior) with cardiogenic shock and was being treated for the same. She is still on ventilator.
- 2. It was further noted that some urgent decisions with regard to her complications were required to be made, which only the applicant can make.
- 3. Ms. Bandhopadhyay, learned ASC has verified the medical history of the mother of the applicant and the same is found to be correct.
- 4. The Nominal Roll is also on record.
- 5. For the aforesaid reasons, the applicant is granted interim bail for a period of 14 days IN F.I.R. NO.129/2016 P.S. ECONOMIC OFFENCES WING, F.I.R. NO.56/2016 P.S.–ECONOMIC

OFFENCES WING, F.I.R. NO.97/2016 P.S. - RAJOURI GARDEN to attend to his ailing mother and take necessary medical decisions at the earliest on the following terms and conditions:-

- (i) The applicant shall furnish a personal bond in the sum of Rs. 20,000/- with one surety of the like amount to the satisfaction of the Jail Superintendent;
- (ii) He shall appear before the Court as and when the matter is taken up for hearing;
- (iii) The applicant shall provide his mobile number to the Investigating Officer (IO) concerned- at the time of release, which shall be kept in working condition at all times. The applicant shall not switch off, or change the same without prior intimation to the IO concerned, during the period of his bail;
- (iv) The applicant shall not leave the National capital Region/NCT of Delhi during the bail period without prior permission of the court;
- (v) The applicant shall drop a Google pin location from his mobile phone to the IO concerned so as to inform the IO about the current location of him;
- (vi) In case he changes his address, he will inform the IO concerned and this Court also;
- (vii) The applicant shall not indulge in any criminal activity during the bail period;
- (viii) The applicant shall not communicate with, or come into contact with any of the prosecution witnesses, or any member of the victim's family, or tamper with the evidence of the case.

- 6. On the expiry of the period of his interim bail, he shall surrender himself to the Jail Superintendent.
- 7. The petition stands disposed of in the aforesaid terms.
