portal has become operational for payment of profession fees to the Standing

Counsels.

2. Mr. Santosh Kumar Tripathi, learned Standing Counsel, states that the

process is still a lengthy one and the Counsel is required to download the

form, fill details of the bill and then upload the signed and scanned copy

again on the portal. He states that some provision of OTP based system

should be made available in the OSWS portal which will reduce the time

period in sanctioning the bills. Resultantly, the State is directed to ensure

that some provision of OTP based signature is made available as the present

process is cumbersome and defeats the purpose of seamless submission of

bills. Let the same be done within four weeks' from today.

3. It has also been brought to the notice of this Court that *vide* Order

dated 25.08.2020, this Court had directed the Respondents to clear the

pending bills and the same has not been done so far. Let the exercise be

concluded positively before the next date of hearing and the Respondents

shall make all endeavour in clearing the bills which are pending till date.
