## **BAIL APPLN. 1949/2023**

- 1. This is a petition filed by the petitioner under Section 439 Cr.P.C. seeking interim bail for a period of 45 days in case FIR No. 27/2023 under Sections 467/471/420/34 IPC registered at Police Station Crime Branch.
- 2. Issue notice. Learned APP for the State appears on advance notice and accepts notice.
- 3. It is submitted by the counsel for the petitioner that wife of the petitioner has delivered a baby boy on 26.05.2023. He further submitted that his wife is weak, and she is not able to take care of new born child properly. He further submitted that petitioner being the father wants to meet his new born baby and would also make arrangements of funds for his wife

and new born baby. He further submitted that in case petitioner is granted interim bail, he would surrender at the end of the expiry of the interim bail period and would not seek any further extension.

- 4. Learned APP submitted that the factum of birth of child has been verified by the IO, and State has no objection if some relief is granted to the petitioner.
- 5. Keeping in view the entire circumstances, and the fact that petitioner is now a father of a newly born child, and has a moment to cherish his life as a father, petition is allowed and the petitioner is admitted to interim bail for a period of 45 days from the date of his release subject to following terms and conditions:-
- a. The applicant/petitioner shall furnish a personal bond in the sum of Rs.20,000/- with one surety of the like amount to the satisfaction of the Jail Superintendent;
- b. The applicant/petitioner shall not leave the territorial jurisdiction of the State of NCT of Delhi without prior permission of this Court;
- c. The applicant/petitioner shall furnish to the IO/SHO/Jail Superintendent concerned his mobile number on which the applicant may be contacted at any time and shall ensure that the number is kept active and switched-on at all times;
- d. The applicant/petitioner shall drop a Google pin location from his mobile phone to the IO concerned so as to show his whereabouts everyday;
- e. The applicant/petitioner shall surrender before the Jail Authorities at the expiry of the period of interim bail;
