<u>ORDER</u>

This Criminal Petition is filed under Section 482 of Code of Criminal Procedure (for short 'Cr.P.C.') by the petitioner/accused No.7 to quash the proceedings against him as alleged in Crime No.260 of 2023 on the file of the Market Police Station, Hyderabad District, registered for the offences under Sections 188, 290 and 341 read with Section 34 of the Indian Penal Code (for short 'IPC') and Section 21/76 of City Police Act.

2. Learned counsel for the petitioner submitted that the contents of the complaint do not attract either the provisions of Sections 188, 290 and 341 IPC or the provisions of Section 21/76 of City Police Act. He submitted that permission was granted and the Shobha Yatra was conducted in accordance with the said permission and the allegations are made without any basis. He has drawn the attention of this Court to the relevant legal provisions. He further submitted that the said Shobha Yatra has already been over.

4. Having regard to the contents of the complaint, this Court is satisfied that the provisions of the alleged offences are not applicable to this case, particularly Sections 290 and 341 IPC. In view of the same, the proceedings in Crime No.260 of 2023 on the file of the Market Police Station, Hyderabad District are quashed.

5. Accordingly, this Criminal Petition is allowed.

6. Pending miscellaneous petitions, if any, in this Criminal Petition shall stand closed.
