JUDGMENT

The petitioner alleges that the third respondent is attempting to flee from law, though he had committed rape on her; and therefore, pleads that respondents 1 and 2 be directed to impound his passport forthwith.

- 2. However, Smt.Aparna C.Menon learned counsel for the third respondent, submitted that her client has already obtained an order of bail from this Court, wherein, the only condition is that he must mark his appearance and sign before the Investigating Officer every Saturday, until the final report is filed. She submitted that, therefore, her client cannot leave India, even if he wants so; and that he does not intend to do so, without obtaining further orders from the competent Court.
- 3. Recording the afore submissions of the third respondent and since he renders it luculent that the relief sought for by the petitioner is not necessary to be granted, I close this writ petition; however, leaving liberty to the petitioner to approach this Court again, if circumstances warrant so in future; for which purpose, all rival contentions are left open.

I am persuaded to the afore course also because,

Sri.Gireesh Kumar - learned Central Government Counsel, submitted that the impounding of the passport of any person is an extreme step, which can be done only under the orders of Courts. I also record his submission that since there are no conditions imposed on the bail order of the third respondent to such effect, the impounding of his passport cannot be done merely on the asking of the petitioner.
