# **ORDER**

As far as the Medical Colleges in Kerala are concerned, Government have now, pending this lis and stated to advert to the earlier interim orders, come out with a new Government Order, bearing number G.O.(Rt)No.2887/2022/H&FWD dated 06.12.2020, which relaxes the timings of the students hostels substantially.

- 2. As per this order, even though the gates of the hostels both for boys and girls are to close by 9.30 p.m, it gives sufficient leeway to the students to enter it after that time subject to certain bare minimum conditions except for the first year students, who are yet not used to the new environment.
- 3. Smt.Parvathy Menon learned Standing Counsel for the Kerala Women's Commission, submitted that her client also supports the afore Government Order, since it does not brook

of any gender discrimination and makes certain rules applicable to all hostels to maintain discipline.

4. *Prima facie*, I find this order to be a welcome step forward; and am hence of the view that it should be implemented forthwith, subject to evaluation, whether further modifications to it is requisite, to be made by this Court in due course.

Therefore, I direct all Principals and other concerned Authorities of the Medical Colleges to act in terms of the afore Government Order with immediate effect.
