# JUDGMENT

The petitioner participated in 'Kuchipudi' in the Sub-District School Kalolsavam, but secured only Rank No.2. She says that since the stage on which she performed has not been properly cleared after the earlier performances, certain pins and sharp objects therein caused her feet to be injured; and that there was also a problem with respect to the opening of the curtain of the venue because, someone had used a ladder for such purpose, which caused fear in her mind that it would collapse on her. She adds that the feedback to the stage from the loud speaker system was also woefully insufficient, thus incapacitating her from hearing the sound clearly; and hence that her performance could not be to the mark she expected.

2. The petitioner says that, however, when she preferred an Appeal against this before the Appellate Committee, it has been rejected through Ext.P3, without citing any reason, but merely saying that the "Appeal stands rejected". She thus prays that Ext.P3 be set aside and she be given an opportunity to participate in the District Level School Kalolsavam.

3. Sri.Sunil Kumar Kuriakose – learned Government Pleader, in response to the afore submissions of Smt.Preeja V.P. - learned counsel for the petitioner, submitted that it has been well settled by a

WP(C) NO. 38620 OF 2023 3 judgment of this Court in *Devna Sumesh v. State of Kerala* [2022 KHC Online 8081] that once the Appellate Order is issued, the petitioner cannot seek any relief, either by way of latitude or indulgence. He added that since the Appellate Committee had assessed the Appeal of the petitioner correctly, she cannot seek any further relief in this writ petition.

4. I am afraid that I cannot find favour with the afore submissions of the learned Government Pleader because, unlike many other cases, this is one in which the petitioner has specified the reasons which caused her apparent prejudice. She says that there were safety pins in the stage, which thrust into her feet; and that there was a problem with respect to the raising of the curtain, which caused her fear that it will collapse on her. She also says that there was a problem with the loud speaker system, which caused her not to hear the song properly and that all this caused prejudice to her.

5. When such specific contentions are raised in the Appeal, the Appellate Panel ought to have considered it properly, including by assessing the video recording; but nothing is discernible from Ext.P3 that this has been done. On the contrary, it merely says that the Appeal of the petitioner stands rejected without citing any reason.

6. Obviously, this Court finds in favour of the petitioner.

In the afore circumstances, this writ petition is allowed and Ext.P3 is set aside; with a consequential direction to the organizers to allow the petitioner to participate in 'Kuchipudi' in the District Level School Kalsavam to commence tomorrow (22.11.2023). All resultant benefits shall also be made available to her.
