Writ Petition (Civil) praying inter alia that in the circumstances stated in the affidavit filed along with the WP(C) the High Court be pleased to i. stay the operation and implementation of Exhibits P2 P5 and P8 penalty challans pending disposal of the Writ Petition (Civil) ii. restrain the Respondents and officials under them in detaining vehicles having a valid All India Tourist Permits on the strength of Exhibit P1 circular and from imposing penalty on the said vehicles alleging violation of section 66(1) of the Motor Vehicle Act, 1988 for the reason that the passengers in the vehicle are boarding alighting from different points enroute, pending disposal of the Writ Petition (Civil).

This petition coming on for orders upon perusing the petition and the affidavit filed in support of WP(C) and upon hearing the arguments of SRI. M.R.SARIN, Advocate for the Petitioners, the court passed the following:

ORDER

Sri. P.Santhosh Kumar, learned Special Government Pleader submits that though the petitioners' vehicles have all India tourist permit in effect, they are operating as stage carriage, in violation of the permit conditions. Therefore, he submits that the penalty challans had been issued to the petitioners for violating the all India tourist permit conditions.

- 2. On the other hand, learned counsel for the petitioners submits that similar matters are pending before this Court and this Court has granted interim orders.
- 3. All India tourist vehicles cannot be permitted to operate as stage carriage as it is detriment to the stage carriage operators including KSRTC. If the petitioners are violating the permit conditions, they are liable to be fined. The matter is seeking attention of this Court and therefore, as an interim basis it is provided that the petitioners should pay 50% of the challan amount and the remaining amount

shall be subject to the outcome of the writ petition. The Authority will be free to take appropriate action, if they find the vehicles are operating in violation of the permit conditions.
