Petitioners are Sri Lankan citizens and are the children of the accused in R.C.03/2023/NIA/KOC and R.C.04/2023/NIA/KOC. Their parents were arrested by the National Investigation Agency in connection with the above mentioned two crimes. Petitioners were also taken into custody along with their parents. Thereafter, they have been detained at the building of the Gandhibhavan International Trust, Pathanapuram, Kollam, which is a Transit Home. The petitioners have been continuing in the said Transit Home for the last more than two years. Since petitioners are not involved in any criminal offence, they have approached this Court seeking a declaration that their continued detention is unconstitutional and also seek an appropriate direction to the 1st respondent to take immediate steps to facilitate their return to Sri Lanka. Directions are also sought for processing and issuing the necessary travel and exit documents, including



the exit permits.

2. A statement has been filed on behalf of the 1st respondent stating that the petitioners are holders of valid Sri Lankan passports and their Visas had expired on 14.10.2022. It is also stated that in BA No.7981 of 2022 dated 11.11.2022, this Court had directed the State Government to ensure that petitioners reside at the Gandhibhavan National Trust, Pathanapuram, Kollam until further orders, and thereafter they are residing in the said Transit Home. The statement further mentions that the 1st respondent has no objection to initiate the procedure for their repatriation to Sri Lanka, if they are not required for any further investigation by the National Investigation Agency. It is also prayed that this Court may direct the petitioners to apply for an exit permit, subject to the condition that they are not required by any investigating agency for further enquiry.

3. I have heard Smt.Niharika Hema Raj, the learned counsel for the petitioners as well as the learned Deputy Solicitor General of India.

4. During the course of hearing, the learned Deputy

Solicitor General of India, upon instructions, submitted that the petitioners are not wanted by the National Investigation Agency for any enquiry or investigation. It was further submitted that petitioners are not wanted by any investigating agency and hence respondents have no objection to the petitioners exiting the country.

5. Since there is no dispute from the side of the respondents to the petitioners' exit, and they are also not wanted by any investigating agency in the country, I am of the view that the petitioners ought to be permitted to leave India at the earliest. The continued detention of the petitioners in India will amount to a deprivation of the right to life and liberty of the petitioners. Since petitioners visas have expired, the 1st respondent must initiate necessary steps to issue an exit permit and other travel documents at the earliest to enable their return to Sri Lanka.

6. In the result, there will be a direction to the 1st respondent to take immediate steps to facilitate the petitioners return to Sri Lanka by issuing the required exit permit and other travel documents at the earliest at any rate not later

than two weeks from the date of application for such exit permit. The 1st respondent shall ensure that petitioners exit the country at the earliest and if any hurdle is caused, the same shall be overcome at the earliest using the good offices of the 1st respondent.

The writ petition is allowed.
