ORDER

IA No. 210775/2025 (application for impleadment)

- 1. IA No. 210775/2025 is allowed, as prayed for.

- 7. During the course of the hearing, Mr. Prashant Bhushan, learned counsel for the petitioner, has referred to the order dated 20.08.2025 passed by the Division Bench of the Calcutta High Court in WPA(H) No. 50/2025 (Bhodu Sekh v. Union of India & Ors.). We are informed that the above-stated petition seeking a Writ of Habeas Corpus has been filed for the release of Sunali Bibi. However, the writ petition was adjourned to 10.09.2025 as the pendency of the present proceedings was brought to the notice of the High Court.
- 8. In this regard, we clarify that the issue raised in the writ petition pending before this Court is entirely different and has no bearing on the writ petition seeking a Writ of Habeas Corpus pending before the High Court. Consequently, we request the High

- 9. Liberty is granted to raise the issue of ascertainment of the citizenship status of Sunali Bibi or her family members and/or other petitioners before the High Court in the above-stated writ petition/similar matters, which shall be considered in accordance with law.

- 11. SLP (Civil) Diary No. 49031/2025 is taken on Board. The same is disposed of, as infructuous.
