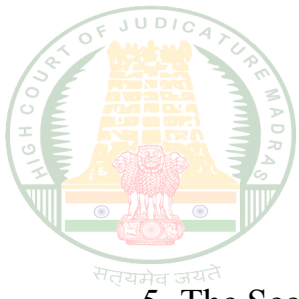

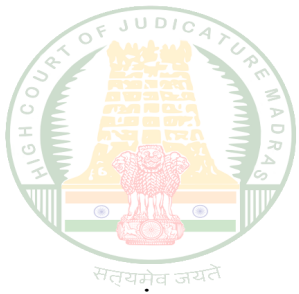

COMMON ORDER

Petition seeking bail in respect of Crime No.228 of 2024 registered for
the offences punishable under Sections 191(2), 126, 296(b), 115(2), 109, 351(3)
of BNS, 2023, which was, later, altered into one under Sections 191(2), 126,
296(b), 115(2), 109, 351(3), 103 of BNS, is on board for consideration.

2. The incarceration of the petitioners being from 04.10.2024 pleading

innocence on the part of the petitioners and false implication in the case, the learned counsel for the petitioners seeks indulgence of this Court. He also submits that the petitioners have nothing to do with the alleged offence and they are ready to abide by any stringent condition that may be imposed by this court.

3. The case of the prosecution as put forth by the learned Government Advocate (Criminal Side) appearing for the respondent police, opposing for grant of bail, is that the petitioners, who are pursuing their bachelor degree in Pachayappa's College, in a group rivalry against another group of students of another College in Chennai City, had assaulted a student by name Sundar and caused his death. He would further submit that there are seven accused in this case and the investigation in this case is still pending.

4. Having heard the learned counsel for the petitioners and the learned Government Advocate (Criminal Side) for the respondent Police and perused the materials available on record, this court is inclined to grant bail to the petitioners with certain conditions and accordingly, the petitioners are ordered to be released on bail on their executing separate bond each for a sum of **Rs.15,000/- (Rupees Fifteen Thousand only)** with **two sureties (out of which, one of the sureties**

should be either the father or mother of the petitioners), each for a like sum to the satisfaction of the learned II Metropolitan Magistrate, Egmore, and on further conditions that :

[a] the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

[b] the petitioners in CrI.O.P.Nos.27676 & 27493 of 2024 shall report before the Resident Medical Officer, Rajiv Gandhi Government General Hospital, Chennai, who shall depute them to the Trauma Ward to assist the Attendants therein between 10.00 am to 2.00 pm., from their date of release till 19.12.2024 ;

[c] the petitioners in CrI.O.P.Nos.27688 & 28311 of 2024 shall report before the Resident Medical Officer, Government Kilpauk Medical College Hospital, Chennai, who shall depute them to the Trauma Ward to assist the Attendants therein between 10.00 am to 2.00 pm., from their date of release till 19.12.2024 ;

[d] the petitioners shall appear before this Court on 20.12.2024 along with Reports of the RMO concerned in this regard;

[e] each petitioner shall, in his own handwriting, submit before this Court a write-up of his experience in the

trauma ward during the above period;

[f] the petitioners shall not abscond either during investigation or trial;

[g] the petitioners shall not tamper with evidence or witness either during investigation or trial;

[h] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioners in accordance with law as if the conditions have been imposed and the petitioners released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in *P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]*;

[i] If the accused thereafter abscond, a fresh FIR can be registered under Section 269 of B.N.S.

5. Post the matter on **20.12.2024** for reporting compliance.
