## **ORDER**

On a request made by this Court during the earlier hearing of these cases, the Counsel appearing for the Enforcement Directorate (for short, 'ED') had made available some materials to show that there are some utilisations of the funds that had been received through Masala Bonds, which need explanation.

I have gone through the files placed before me and I do not think that at this stage, the details which have been placed before me can be disclosed, particularly since these are materials collected as part of investigation, which may have to be put to the persons who are summoned as part of the investigation. However, I find that some transactions require explanations and the manner in which the explanations are to be obtained by the ED will be considered at a later stage. The elections are due and the petitioner in W.P.(C) No.3719/2024 is also a candidate. I do not think it is proper to disturb a candidate who is contesting an election for a representation in the

Parliament at this stage, particularly since only less than a month is available for completing the elections. I hence adjourn these cases for detailed hearing to 22.05.2024.
