arrest Mr. Virender Dev Dixit, an accused in a number of criminal cases.

2. This Court is satisfied with the attempts and progress made by CBI in the matter, however, as CBI is still in the process of apprehending Mr. Virender Dev Dixit, the report is being returned back in sealed cover to CBI. CBI has furnished details of certain bank accounts being operated by the accused, based upon the input received from Financial Intelligence Unit. CBI is free to freeze all such accounts, in accordance with law, if so advised.

- 3. CBI is granted six weeks' time to take further appropriate steps towards his arrest and file a fresh status report to that effect.
- 4. Re-notify on 24th November, 2023.
