The case is taken up today as 25.11.2025 was declared holiday on the occasion of 350th anniversary of 'Guru Teg Bahadur's Martyrdom Day'.

- 1. By way of the present application, the applicant seeks grant of interim bail in FIR bearing no. 126/2020, registered at Police Station Paschim Vihar, Delhi, for the commission of offences punishable under Sections 363/364A/506/120B/34 of the Indian Penal Code, 1860 (hereafter 'IPC').
- 2. The learned counsel appearing on behalf of the applicant/accused argues that applicant was granted interim bail *vide* order dated 04.10.2025 by the learned Trial Court as he is a patient of tuberculosis and was admitted in hospital for treatment and discharged on 23.10.2025 from the hospital. Further, his interim bail was extended *vide* order dated 25.10.2025. It is contended that due to air pollution in Delhi, the applicant is not able to breathe





properly and he had also fainted due to breathing problems. Accordingly, it is prayed that the applicant be released on interim bail.

- 3. The learned APP for the State, on the other hand, argues that the allegations against the accused/applicant are serious in nature. However, he does not dispute the medical condition of the applicant herein.
- 4. This Court has **heard** arguments addressed on behalf of the applicant as well as the State, and has perused the material available on record.
- 5. Considering the overall facts and circumstances of the case, this Court takes note of the fact that the applicant/accused is suffering from Tuberculosis, which is not disputed. This Court further notes that on earlier occasions also, the applicant was granted interim bail and he has never misused the liberty so granted to him. Accordingly, this Court is inclined to grant interim bail for a period of 15 days to the applicant herein, on his furnishing personal bond in the sum of Rs.15,000/- with one surety of the like amount, subject to the satisfaction of the learned Trial Court/Successor Court/Link Court/Duty Judge concerned on the following terms and conditions:
 - i) The applicant shall not leave the country without prior permission of the concerned Court and if the applicant has a passport, he shall surrender the same to the concerned trial court.
 - ii) In case of change of residential address/contact details, the applicant shall promptly inform the same to the concerned Court and IO/SHO concerned.
 - iii) The applicant shall appear regularly before the learned Trial Court, unless exempted.
 - iv) The applicant shall not communicate with, or come into contact





with the complainant or any of the prosecution witnesses, or tamper with the evidence of the case.

- 6. Accordingly, the present bail application stands disposed of.
- 7. It is, however, clarified that nothing expressed hereinabove shall tantamount to an expression of opinion on merits of the case.
- 8. The order be uploaded on the website forthwith.
