This **PETITION** coming on for orders this day, the court passed the following:

ORDER

Heard finally, with the consent of the learned counsel for the parties.

By this writ petition under Article 226 of the Constitution of India, the petitioner is seeking the following relief (s): -

"7. RELIEF PRAYED FOR: -

The petitioner most humbly and respectfully pray before this Hon'ble Court as hereunder: -

- 7.1 That, the instant petition may kindly be allowed and writ of mandamus may kindly be issued to the respondents directing the respondents to pass appropriate orders on the pending application dated 10.05.2006 and representation / notice dated 10.01.2013 filed by the petitioner within a time bound period.
- 7.2 That, the cost of present petition may also be awarded to the petitioner and any other order which this Hon'ble Court may consider appropriate may also be granted in favour of the petitioner."
- 2. Learned counsel for the petitioner has submitted that the representation (s) submitted by the petitioner for sanction to prosecution on 10.05.2006 (Annexure P/4) and thereafter 10.01.2013 (Annexure P/8), but till date, the matter has been kept pending by the respondents; and no orders have been passed on the petitioner's representation.
- **3.** Learned counsel for the respondent / State, on the other hand, has submitted that the representation shall be decided expeditiously.
- 4. In view of the same, this Court finds it expedient to dispose of this petition with a direction to the petitioner to file a fresh application / representation within a period of **two weeks** along with earlier application and other relevant documents before the Chief Secretary to the Government of Madhya Pradesh, Bhopal (respondent No.2) / Competent Authority, who shall decide the same expeditiously, possible preferably within a period of **three months** from the date of receipt of certified copy of this order, in

accordance with law by passing a reasoned and speaking order.

5. With the aforesaid direction, Writ Petition No.19271/2022 stands **disposed of**.

All the other pending interlocutory applications, if any, shall stand **disposed of**.
